

**SPECIFICATIONS:**

DOORS SHOWN AS FLEXIBLE VINYL IMPACT TRAFFIC DOORS, DOUBLE ACTING, SHALL BE MODEL 300-50 DOORS AS MANUFACTURED BY CHASE INDUSTRIES, INC., CINCINNATI, OHIO, TO FIT DOOR OPENING \_\_\_\_\_ WIDE BY \_\_\_\_\_ HIGH.

DOOR SHALL BE CONSTRUCTED OF TWO LAYERS OF 2-PLY HEAVY DUTY BELTING (USDA APPROVED) WITH ANTI-ABRASION SURFACE, LAMINATED BACK-TO-BACK. BRACKET POCKET, BALLOON JAMB SEALS, AND TOP AND BOTTOM WIPER SEALS TO BE 45oz. TWO-PLY VINYL COATED NYLON. ALL PERIMETER EDGES TO BE HEAT SEALED TOGETHER.

DOOR TO UTILIZE TOP MOUNTED GRAVITY-OPERATED HINGING SYSTEM, COMPLETE WITH 1/2" THICK ZINC WALL BRACKET WITH BEARINGS AND 5/8" DIAMETER STEEL ROD ARM.

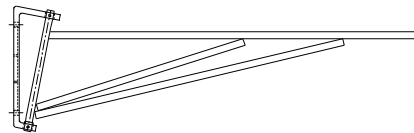
